 Fountain Trace Estates  
 Directions: Cemetery Road to Fountain Trace, left on Autumnstone, left on Lakemere, third house on left in front of the lake.

 1531 Stillwater Court (Lot #128)  
 Fountain Trace Estates  
 Directions: Cemetery Road to Fountain Trace subdivision, turn left on Autumnstone, turn left on Lakemere and right on Stillwater. The house is the third on the right.
